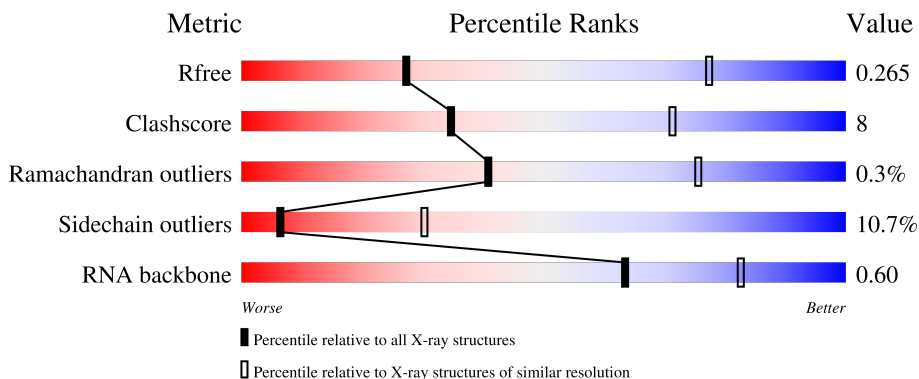
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

X-RAY DIFFRACTION

The reported resolution of this entry is 3.50 Å.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$.

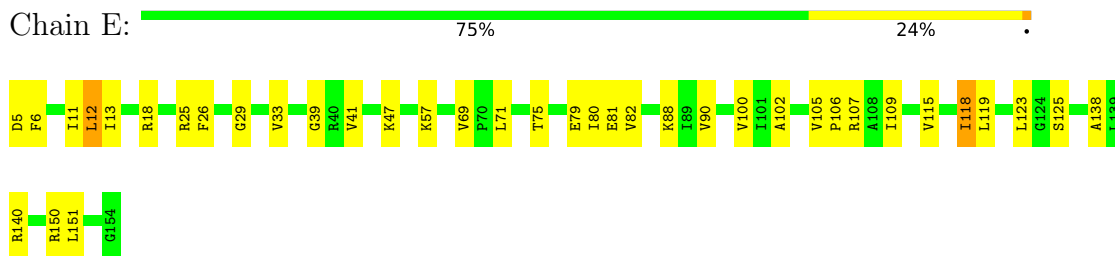
• Molecule 3: 30S ribosomal protein S3



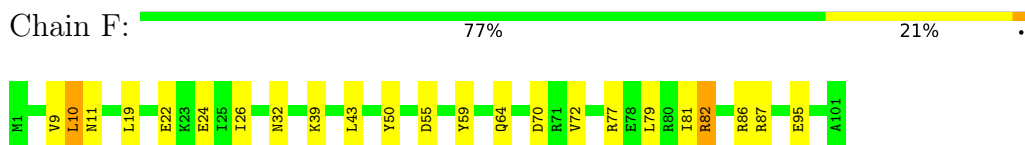

5.1 Standard geometry i

Bond lengths and bond angles in the following residue types are not validated in this section: ZN, MA6, 0TD, MG, 2MG, 5MC, UR3, 4OC, M2G, 7MG, PSU

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).
